Fisher, Nicholas I. and Trewin, Dennis J. (2021)

A Proposal to Enhance National Capability to Manage Epidemics: The Critical Importance of Expert Statistical Input Including Official Statistics. *Statistical Journal of the IAOS*

The paper is policy oriented and addresses decision makers. The paper is tuned to this purpose.

- The title has a very clear message: the importance of statistical expertise for pandemic management.
- Introduction can be read as a management hand-out

Diaz-Bone, Rainer and Horvath, Kenneth (2021)

Official Statistics, Big Data and Civil Society. Introducing the Approach of “economics of Convention” for Understanding the Rise of New Data Worlds and Their Implications.
Statistical Journal of the IAOS

The paper is an outlier in the world of OS for a broad audience of producers of social statistics

- Lots of effort have been given to introduce the theory (history, relation to OS) to the audience.
- References provide further introduction of the theory.
- The (provocative) conclusion that the data world of OS will lose influence and has to find allies could have been given more prominence since paper is part of a discussion

J. Michael Brick, (2013)

Nonresponse and Weighting Adjustments: A Critical Review. *Journal of Official Statistics*

As a clear example of a 'Review' article it describes the current state for the topic.

- The '*A critical review*' in the title is rather ambitious and is not completely covered by the content.
- Especially the discussion lacks to be very concrete compared to the detailed review of earlier approaches.
- The Review part is rather complete and surely will satisfy the audience as giving a useful overview.
- The structure allows the reader to easily pick what he/she is interested in.
- The manuscript does not develop new concepts/approaches but will function very well as a framework for further references.

MacFeely, S.(2020)

Measuring the Sustainable Development Goal Indicators: An Unprecedented Statistical Challenge. *Journal of Official Statistics*

Policy paper providing background information on Global Indicator Framework written for Official Statisticians and a wide audience, raising awareness to the enormous work ahead and (potential) pitfalls.

- The title is (part of) the message.
- The article is a sequence of points of interest representing the different aspects of such a big enterprise.

J.N.K. Rao and Wayne A. Fuller, (2017)

Sample survey theory and methods: Past, present, and future. *Survey Methodology*

This Review paper follows a historical approach, easy to follow and for the readers to orientate in.

- The title fits completely with the content.
- This is a 'landmark' article aiming to generate reflections on the future state of the sampling theory and methods.

Van den Brakel, J., Söhler, E., Daas, P. and Buelens, B. (2017)
Social media as a data source for official statistics; the Dutch Consumer Confidence Index.
Survey Methodology

Expository paper on combining two data sources with the help of multivariate time series techniques.

- The title only mentions the use of social media, not the combination with the traditional survey. The timeseries technique is not mentioned, whereas it is an important part of the article.
- In the abstract this omission is corrected. It is mainly concerned with the techniques involved and does not give a preview of the (mixed) results.
- Both, title and abstract, are incomplete.

De Waal, T., van Delden, A., and Scholtus, S. (2020)
Multi-source Statistics: Basic Situations and Methods. *International Statistical Review*

Review article on a narrow subject. The paper is for all statisticians working with multi-source data, a rather broad audience.

- The first sections are used to make the term ‘basic situation’ from the title more precise. This is the essential part of the paper.
- When the basic situations (8) are described, the subsequent sections give the methods, literature and examples for each situation.
- The organization into situations make the article helpful and accessible.

Das, S., and Haslett, S. (2019)

A Comparison of Methods for Poverty Estimation in Developing Countries. *International Statistical Review*

The paper is rather technical and is meant for a specialist audience

- One of the main conclusions is given in the abstract. The abstract will read by a wider audience.
- The title does not cover the content of the paper. It mentions developing countries, whereas two of the three methods are applied only in Europe and the third mainly in developing countries.

James Brown, et.al; (2020)

Exploring developments in population size estimation. *The Survey Statistician*

The manuscript is a combination of a Review article and a Technical note. In fact it is a report of a workshop.

- Readers must be more advanced and expert in the domain.
- The title leaves very open what the content of the manuscript exactly is. Readers will only learn what it is about when reading the abstract and manuscript.
- The structure follows the examples as discussed in the workshop, and does not really give an easy to understand flow.

Puts, M. and Daas, P. (2021)

Machine Learning from the Perspective of Official Statistics. *The Survey Statistician*

Expository paper with a non-technical and general approach for non-technical Official Statisticians.

- The title covers almost completely the conceptual frame of the paper: Machine Learning from the perspective of the quality dimensions of the EES in OS.
- The idea behind the paper is simple and insightful. It is an approach on 'first principles' and there is no need for an extensive theoretical section.
